Laura Atria

Laura Atria is an experienced public art professional, serving as the Public Art and Artist in Residence Program Manager for the City of Pompano Beach and as President of FAPAP. With over 14 years in public art administration, she has developed impactful programs, served on boards like the Broward Cultural Council, and secured major grants, including a \$1 million Bloomberg Philanthropies Grant. She holds a dual degree from FAU. As a studio artist, her

work explores voyeurism, femininity, and self-healing. She has received multiple Broward Cultural Division Grants and was commissioned for President Joe Biden's 2020 campaign. As a visual artist and Public Arts administrator, Atria blends academic expertise with hands-on experience to the projects she encounters.



Elena Bowen

RLA Associate Conservator and Professional Associate of the AIC, she holds an M.A. in Conservation from the UCLA/Getty Program and a B.A. in Studio Art from Wellesley College. Elena manages public sculpture collections at several universities in south Florida and serves as lead conservator managing the museum quality collections for a number of private clients. Prior to joining RLA, she completed pre-program internships at Vizcaya Museum and Gardens,

Caryatid Conservation, and the Penn Museum. She completed graduate internships at the Fowler Museum at UCLA, the Hirshhorn Museum and Sculpture Garden, and the Carlos Museum at Emory University. She has worked on archaeological sites in Peru and Greece and has experience working with Native and local communities as well as artist foundations.



Ashley Burke

Ashley Burke is a fine art appraiser and museum professional with 20 years of experience. She is accredited by the Appraisers Association of America with a specialty in Postwar, Contemporary and Emerging Art and holds a master's degree in museum studies from George Washington University. Burke has worked extensively with collectors, museums, municipalities and auction houses around the Tampa Bay Area including the Ringling Museum of Art,

Tampa Museum of Art, Museum of Fine Arts St. Petersburg, City of St. Petersburg Public Art Collection, and Blackwell Auctions. Her practice focuses on the stewardship of collections including developing documentation protocols and long-term preservation plans, exhibition project management and oversight, and providing appraisal services for charitable contributions, insurance, and estate planning.



Oaklianna Caraballo

Oaklianna Caraballo is the Art in State Buildings Specialist at the University of Florida. In addition to public art selection projects for state-funded UF buildings located throughout Florida; she created and implemented an art collections management policy and procedures, which includes oversight of the care and maintenance for over 160 artworks, deaccessioning, and integration of ASB artworks into university digital systems and infrastructure. She is a FAPAP

member since 2006, board member since 2009, president from 2022-2024, and currently on the executive board. Oaklianna serves on the City of Gainesville's Art in Public Places Trust since 2021 and appointed chair in 2024. She received her bachelor's degree from Florida State University and her master's degree in museum studies from the University of Florida.



Melissa Davies

Melissa LeBaron Davies facilitates percent-for-art public art projects and site-specific cultural experiences for the city of Tampa. Davies also oversees collections management and maintenance for the program, which has nearly 800 works in the collection. Davies has worked in arts administration for 25 years with 20 years focused on Public Art administration. She's a Tampa native and received a B.A. from the University of Florida and a Graduate Certificate in

nonprofit management from the University of South Florida. Davies serves on the Board of Directors as an officer on the Florida Association of Public Art Professionals. Also a musician, Davies played bass in local bands for 20 years and is now teaching her six-year-old daughter how to rock.

Nelson Hallonquist – RLA Conservation Director of Operations and Partner, holds a B.A. in Sociology from the University of Central Florida. With RLA since 2015, Nelson is the firm's lead sculpture painter as well as patina specialist, having recently participated in the Getty Conservation Institute's "Bronze Patination for Conservators" workshop. He is versed in the maintenance and treatment of bronze, stainless steel, painted mild steel, ceramic, electronic media, stone,

concrete, fiberglass, wood, glass, and plaster, among other materials. In addition to conservation treatments, maintenances and condition assessments, Nelson works with conservation teams at RLA's studios in Los Angeles and Miami on project planning and implementation.



Iryna Kanishcheva

Iryna Kanishcheva, MBA, is a public art curator, producer, and founder of Monochronicle (monochronicle.com), a platform and consulting agency specializing in public art, creative placemaking, and Al-powered art solutions with proprietary call-to-artist software. Originally from Ukraine and now based in Florida, Iryna has established herself as a leader in the field of public art by producing large-scale murals, art festivals, immersive installations, and

multidisciplinary art initiatives in collaboration with cities, developers, and cultural organizations. Her contributions to enhancing public spaces through art have been recognized with the 2021 Business Arts Award, the 2018 City Beautification Award, and the 2015 Public Art Award.



Rodney Kite-Powell

Rodney Kite-Powell is the Director of the Touchton Map Library at the Tampa Bay History Center, where he joined the staff in 1995. He received a Bachelor of Arts from the University of Florida and a Master of Arts from the University of South Florida – both in the subject of U.S. history. Rodney is an officer with the Philip Lee Phillips Society of the Library of Congress where he serves on the Academic Committee, and in 2019 he was named the official county historian

for Hillsborough County by the Board of County Commissioners. He is the author of three books with a fourth and fifth in progress. Rodney currently lives in Tampa with his wife and two children.
